1. Church Activities (vocations, parish roundtable, parish services, Keep Christ in Christmas, etc.)

Participating in the RSVP program and meeting minimum participation requirements will fulfill all four activity requirements in this category.

2. Community Activities

(feed the hungry, health services, ecology, poverty, helping the aged, etc.)

Participation with Habitat for Humanity or Global Wheelchair Mission and meeting the minimum requirements will fulfill all four activity requirements in this category.

3. Council Activities

(public relations, fraternal recognition, blood donors, athletics, socials, etc.)

Participating with Special Olympics and meeting minimum participation requirements will fulfill all four activity requirements in this category.

4. Culture of Life Activities

(Ultrasound initiative, March for Life, Pregnancy Care Center, baby showers, baby bottle campaign, etc.)

Participating in a local, regional or national March for Life or with the Ultrasound Initiative and meeting the minimum requirements will fulfill all four activity requirements in this category.

5. Youth Activities

(scholarships, Catholic Scouting, etc.)

Participation in the Coats for Kids program or sponsoring a Columbian Squires Circle and meeting minimum requirements will fulfill all four activity requirements in this category.

Knights' Find New Fundraiser a Big Hit

In 2017, The Cardinal Strictch Council 4620 began selling frozen pierogi as a new way to raise money. Not knowing where it would lead, the council found a very strong and successful council fundraiser.

The sale was designed to offer pre-sale orders of meatless pierogi, giving Crown Point parishioners an alternative for to lenten dinners.

The pierogi would be picked up at Alexandra's Home Made Pierogi in Chicago and be distributed out of a truck parked in a parking lot near the square.

The response from both St. Mary's and St. Matthais parishes was overwelming. The amount collected equalled the Fish Fry and allowed the council to give more to local charities.

It was then decided to hold two sales a year, one during lent and one in November, giving the public a chance to purchase pierogi for the holidays.

This year, as every year, Council #4620 works with Habitat for Humanity, has hosted many programs for the youth of the community, and participates in the annual "Tootsie Roll Drive," a campaign for people with intellectual disabilities.

"This is a great moment for our council." said Larry Biegel. "I can say in all honesty, we weren't trying for this award. We try every year to get in as many of the activities time and manpower will allow us to do. This past year we were blessed with both."

The Vocation-300% Club Award is a membership award granted by the Order to agents, recruiters, councils, districts and states based on their ability to reach or surpass their quotas. Council #4620's membership has increased by 10 new members in the past seven years. Recruiting Catholic

men in the 30-45 year-old age range has been the goal to keep the council young and able to continue another 60 years.

The Cardinal Stritch Council #4620 has been recognized as a One Star Council and a Double Star Council. They have earned multiple service and membership awards and citations during their 60 years as Crown Point's Knights of Columbus.
